## BETWEEN

Shri Mathuradas Mohota College of Science, Nagpur (SMM-Nagpur) a premier institution established in 1949 affiliated to RTM Nagpur University, Nagpur and registered under Nagpur Shikshan Mandal having registered office at Shri Mathuradas Mohota College of Science, Sakkardara Square, Umred Road, Nagpur 440009 through the Principal, S. M. Mohota College of Science, Nagpur

## AND

AEON-IAS Academy, Nagpur (AEON-IAS) one of the best institutes for UPSC/MPSC examinations in India, established in 2014, with the vision to be center of excellence and committed to provide 'Result Oriented Approach' to aspirants of UPSC/MPSC, having it's office at 1st floor, Raj kamal Complex, Schabuldthrough the Director, Aeon IAS Academy, Nagpur.

In the spirit of intellectual cooperation, partnering with leading institutions, and guiding for competitive examinations, SMM-Nagpur and AEON-IAS agree to establish a program of collaboration on related matters of mutual interest:

- The purpose of the cooperation is to collaborate to provide weekly Current Affairs sessions, career guidance and personal counselling, mentorship regarding demands and expectations of various competitive examinations conducted by UPSC/MPSC and others.
- AEON-IAS shall be responsible for engaging online or offline classes of two hours duration on Current Affairs either on Saturday or Sunday which would be decided mutually. The timing of classes shall be decided mutually. AEON-IAS shall provide soft copies of study material. In case of offline classes, SMM-Nagpur shall provide required infrastructure facilities in college premises.
- 3. To achieve the goals of this cooperation, both parties agree to
  - a) jointly organize symposia, conferences, workshops, trainings and meetings on aspects related to UPSC/MPSC and other competitive examinations.
  - b) provide basic guidance through "Basic Learning Foundation Course" for UPSC/MPSC Prelims, Mains, and Personal Interview.
  - c) provide basic learning strategies for cracking UPSC/MPSC examination.
- 4. Prior to the initiation of any activity, the specific terms of cooperation and exchange for that project will be discussed and agreed upon in writing by the appropriate responsible representatives of both institutions. The parties designate Dr. Archana M. Sawane as Coordinator from Training and Placement Cell of SMM-Nagpur and Mr. Harshadeep Ghuge as Coordinator from AEON-IAS, to develop and coordinate specific activities under this MoU.
- Both parties understand that there will be no financial implications. SMM-Nagpur shall not seek any finances from AEON-IAS for providing infrastructural or other facilities. AEON-IAS shall not seek any finances from SMM-Nagpur for conduction of classes, guidance or providing study material to students.
- 6. Each party agrees to release and hold the other harmless from and against any claims, damages, liability or costs, to the extent such claims damages, liability or costs do not arise from the negligent or wilful acts or any of its agents or employees in connection with their respective performance under this MoU.
- 7. Both parties agree that while implementing this MoU, they will not engage in unlawful discrimination on the grounds of race, gender, sexual orientation, age, religion, social class, national or ethnic origin or disability.
- 8. Amendments to this MoU may be made at any time after consultation and agreement between the two institutions. Any such amendment must be in writing and signed by both parties.

- 9. This MoU will remain in force for a period of 5 (five) years from the date it is fully executed. The MoU can also be suitably modified, as agreed to by both the parties, to reflect an increased scope, nature of engagement /activities including financial commitments, if any. Prior to the expiration date, the MoU may be reviewed for possible renewal for a further 5 years period. In addition, either party may terminate the MoU in advance of its normal expiration by providing the other with six months' prior written notice. However, for early termination of MoU, all the ongoing activities will continue till completion of commitments and obligations of the activity.
- 10. This MoU does not imply supplying aspirant candidates from SMM-Nagpur to AEON-IAS.
- 11. Neither of the parties signing this MoU shall use name, logo, and vision statement of the other party for the sake of advertisement or proliferation of activities otherwise indicated. The MoU shall stand terminated automatically if found so.
- 12. This MoU has been executed in two originals; one of these has been retained by **SMM-Nagpur** and the other by **AEON-IAS**.
